Remember to pay your condo fees on time. Nearly everyone does - the late people, you know who you are. The association needs your fees on time each month in order to effectively operate the community. Also, Sec. II residents, please remember to round up to the nearest dollar. No cents please! WHY? AND WHERE? FORUM I & FORUM II

Forum was built in the late 1960's. Although not the first condo in St. Louis County it is one of the earliest.. The developer was David Levinson [not related to the current Levinson Homes in this region]. In talking with Bob Sands, former board member and president of Forum II for a total of 15 + years I learned that he closed on his unit in February of 1969.

When the first phase of construction was complete the property was turned over to a board of directors. When the second phase was completed a second board of directors was appointed (Forum II) – this relationship has been maintained since completion of this complex since it's completion in 1971.
