# IT'S A BIG PROBLEM – IT'S NOT CUTE

Early this month one of our residents was bitten four times on the arm and hand while placing trash in a dumpster.

# The bites came from a raccoon.



Raccoons are capable of transmitting rabies, canine distemper and parvovirus to domestic dogs and rabies and roundworms to humans.

These animals live in the creeks and come to Forum to forage in our dumpsters. Forum management has been attempting to trap and remove these pests but we have been advised by St Louis County Health Dept that we must discontinue this effort because we are not 'licensed' to handle these animals (neither is St Louis County Health Dept) – so for the moment our hands are tied. We are pursuing other avenues.

To complicate the problem – some of our residents foster the survival of these dangerous pests by feeding them and by providing methods for them to climb out of the dumpsters (boards etc placed in a dumpster when trash is low and raccoons are trapped).

# What can you do?

1) Open the dumpsters carefully when dumping trash. It is less likely that that the raccoons will be present during the day but we have spotted them many times in broad daylight.

2) If you place a tablespoon of appropriate incide of a hor of trash before

2) If you place a tablespoon of ammonia inside of a bag of trash before placing it in the dumpster allure of that bag will be gone. 3 If you see a neighbor enabling these animals to flourish:

#### SPRINGTIME INVASION

Over the next two days and two more trips to Home Depot for traps, I killed 7 mice in my kitchen. After much experiment, I found that peanut butter is the most effective way to bait a mouse trap.

Stopke Pet Control came a couple of days after Bill Calliot contacted them, and they laid "pet-safe" poison traps along the outside of my building and in my kitchen. This seemed to have solved the problem, until I caught one more mouse about 60 days later. It's been three months now since I've seen a sign of mice in my unit."
